CLIMATE LEADER TRAINING AGREEMENT

The Australian Conservation Foundation (ACF) is Australia's leading national not-for-profit environment organisation committed to inspiring people to achieve a healthy environment for all Australians. ACF works with the community, business and government to protect, restore and sustain our environment.

THE ALLIANCE FOR CLIMATE PROTECTION doing business as THE CLIMATE REALITY PROJECT, a District of Columbia, United States, nonprofit corporation exempt from taxation under Internal Revenue Code § 501(c)(3) ("TCRP")

ACF has undertaken to be TCRP's Australian partner as designated supporter of Al Gore's Climate Change Leadership Program in Australia (the 'Project'). TCRP Australia is also the coordinating hub for the Asia - Pacific region.

In the Asia – Pacific region, TCRP has official branches in Australia, India, Indonesia and China.

I understand, acknowledge and agree that:

1. I will receive training from ACF and TCRP for the sole purpose of making presentations and other related project activities over the next 12 months about the threat of and solutions to global warming in my community;
2. All materials and information provided by ACF and/or TCRP, (including computer software programs), are to be used solely for the purpose of making these presentations, and that these materials may not be stored, used, sold, or reproduced for any other purpose;
3. In my role as a volunteer Climate Leader for ACF and TCRP, I will not accept any payment, pecuniary or otherwise from ACF, TCRP or any other person, entity or organisation in return for making a presentation. No other person or organisation is entitled to charge for my services in my role as a Climate Leader. Any incidental costs that may be incurred in a presentation are my own responsibility;
4. Other parties, individuals or organisations are not to profit from my presentation either directly or indirectly;
5. Although external individuals (not employees or representatives of ACF or TCRP) may assist me in both the preparation and facilitation of my presentation, that under no

circumstances are such individuals to be held out to be representatives of ACF or TCRP and are not to co-present in relation to the Project in any circumstances;

6. All information, materials, and computer programs provided to me are copyrighted and licensed to TCRP and/or Al Gore and/or ACF, and may not be transferred or licensed to any other party for any purpose whatsoever;
7. I am acting as a volunteer, not an agent or employee or contractor of ACF, TCRP or Al Gore, and have no authority to make binding commitments or to enter into contracts for or on behalf of ACF, TCRP or Al Gore;
8. I am not authorised to make public statements relating to the operations or policies of ACF and/or TCRP or to speak publicly for or on behalf of ACF and/or TCRP. The Project is a non-partisan program of education, awareness and mobilisation of change. ACF is a non-partisan environmental charity and activities should not contain content that could be perceived as biased or partisan. I have read and understood the list of measures listed at Schedule 1 to this Agreement to minimise any confusion or perceived political bias, whilst acting in the best interests of the Project's protocols and philosophies;
9. I will not divulge details of the training program, location or other information relating to the partners, trainers or other participants without the prior permission of ACF and TCRP;

10. I agree that I have committed to making a minimum of ten (10) activities within one (1) year of the completion of my training with ACF and/or TCRP. Activities include:

- Presenting the new slideshow material
- Engage with the media including writing letters or opinion piece for local or national newspapers, giving interviews or calling talk back radio
- Engage with government representatives including meeting/calling them and making submissions
- Engage with business networks and other organisations including presenting, holding meetings or roundtables

I will be responsible for the preparation and execution of all my activities and will notify ACF immediately upon completion of my tenth activity;

11. All my activities will be consistent with the spirit, information, materials and environmental messages conveyed during my training;
12. I will reasonably frequently (at least quarterly) advise ACF of progress, outcomes and feedback from my activities;
13.
 - a) My name, biographical information and any images taken of me during the training sessions may be used for promotional purposes in relationship to the Project;

- b) My contact details may be shared with other trainees for the purposes of keeping in touch and supporting one another after the summit;
 - c) Video footage and photographs of me may be used in ACF or TCRP publicity material or may be made available in any format to the media in furtherance of the Project; and
 - d) Subject to my prior notification, I am willing to speak to the media in the interests of the Project.
14. ACF may terminate this Agreement with immediate effect for any reason whatsoever. Without limitation, this Agreement may be terminated as a result of any misconduct including engaging in behaviour that could be considered intimidating, insulting, disruptive, offensive or discriminatory, or that may otherwise affect the reputation of ACF, TCRP or Al Gore.
15. Upon completion of the Project or termination of this Agreement and at the request of ACF I will return all training and other material relating to the Project, ACF or TCRP (including all copies electronic or otherwise) to ACF; and
16. To the full extent permitted by applicable law, I hereby waive all claims against ACF, TCRP or Al Gore arising out of or in connection with this Agreement and/or any act or omission by ACF, TCRP or Al Gore (except for claims relating to the intellectual ownership of, and/or factual accuracy of, content provided to me for my use as a Climate Leader). I agree to indemnify ACF, TCRP and Al Gore and their respective employees, agents, successors and assignees for any costs, damages or other liabilities they may incur as a result of my performance of this Agreement or any act or omission by me in connection with this Agreement.

Schedule 1 (refer paragraph 8)

- If approached by a member of a political party for an activity, it would be courteous and professional to at least offer your services to other major political parties in that area;
- The activities cannot be tied to or affiliated in any circumstance to a fundraising exercise for the political party;
- In regard to publicity, the promotion of the event cannot be co-branded between TCRP, ACF and the political party;
- The members of other parties should be invited to the event in the spirit of uniting the community on the issue;
- ACF is a non-partisan environmental charity and activities should not contain content that could be perceived as biased or partisan. If participants are asked directly about partisan political matters, they may (1) direct the audience to ACF's assessments of the policies of the parties, as they become available; (2) discuss ACF's national agenda on climate change; or (3) respond that the purpose of the activity is on the real impact of climate change on Australia and the world, and people should make up their own minds about whether particular policies will be adequate and effective in preventing a climate catastrophe;
- ACF and TCRP should be notified prior to all events that are tied to a political party.

If you intend to stand for political office, you need to alert the ACF and the TCRP immediately so that the appropriate procedures to ensure there is no conflict with the non-partisan aims of the Project can be followed. A copy of those procedures can be supplied upon request.
